In pursuance of the provisions of clause (3) of Article 348 of the Constitution, the Governor is pleased to order the publication of the following English translation of Government notification No.

NOTIFICATION

No. 342/24-P-3-2018-~~340~~(35)/18
Lucknow Dated 28 February, 2018.

WHEREAS the Uttar Pradesh Information Technology & Start-UP Policy, 2017, has been approved by the Cabinet in its meeting dated 13-12-2017.

AND WHEREAS it has been provided in para 5.1.3 & 6.1 of the said Policy that all new units functional from the date of issuance of the said Policy shall be entitled for 100% exemption from electricity duty for a period of 10 years and eligible incubators/Accelerators will be exempted from Electricity Duty for a period of 5 years.

NOW THEREFORE in exercise of the powers under sub-section (4) of section-3 of the Uttar Pradesh Electricity (Duty) Act, 1952 (U.P. Act no. 33 of 1952) the Governor, having regard to the prevailing charges for supply of energy in any area of the State of Uttar Pradesh, the generating capacity of any part, the need to promote industrial production generally is pleased to direct that all new IT/ITeS units operational after the issuance of said policy. Shall be entitled for 100% exemption from electricity duty for a period of 10 years and eligible incubators/Accelerators will be exempted from Electricity Duty for a period of 5 years.
